EMERGENCY RESPONSES – ACTION PLAN

In all instances, two emergency GO bags; each equipped with first aid kits, copies of Emergency Evacuation forms, extra updated JagCare rosters, flashlights, and portable cellphone chargers, are always available. Extra first aid kits are on site at all times. A battery powered NOAA radio is always on and available for updates. The JagCare site cell phone, a two-way radio provided to JagCare, along with staff cell phones are on site to ensure access to information.

JagCare Staff undergo a 5 clock hour FEMA training prior to employment.

Shelter-In-Place

In the case of tornado, flooding and other severe weather, provided it is safe to do so, JagCare Staff and Students will evacuate the JagCare temp building and take shelter inside the gymnasium on the east side of the school until the threat has passed. Students and staff will be accounted for. Parents are authorized to shelter with the program.

<u>Lockdown</u>

Students are accounted for; all will be kept in the interior of the facility, out of sight. Windows are locked, window shades are drawn closed, all exterior doors automatically lock when closed, and complete silence is maintained until all clear is received from the responders. Sign-in and sign-out are suspended until an all clear is given.

<u>Secure</u>

Everyone is secured and accounted for in the building, all exterior doors automatically lock when closed and all windows are locked when closed. Business as usual, everyone must remain inside until we receive an all clear from the responders. Parents are not authorized to enter JagCare's building.

Fire

Students and Staff will be evacuated together as quickly as possible and meet in the west-side parking lot. Staff will take attendance to account for all students. Sign-in and sign-out will be suspended until an all clear is given.

Evacuation

In the event of an evacuation emergency, JagCare will follow the guidance of JEFFCO School District Emergency Personnel. JagCare has a primary designated offsite reunification location, which will be used if available. If the primary designated reunification site is not available, the second or out of neighborhood evacuation sites will be used.

Students and Staff will be evacuated together with all Staff in charge, taking the 2 emergency **GO** bags. In the event JagCare needs to be evacuated by windows, students will be placed out first, using any means necessary to place students safely on the ground outside of the building.

Transportation to Reunification Sites

Students will walk to reunification sites. Permanent or temporarily physically disabled students will be accompanied by an assigned staff.

If necessary, transportation will be arranged for out of neighborhood evacuation.

Notifications



Release and Parent Reunification
